# WORKS IN PROGRESS

*Constructing Sexual Misconduct: Student Understandings and Institutional Legitimacy.* This qualitative study analyzes open-ended responses from college students about what they believe constitutes sexual misconduct and how they would respond to such experiences. The paper offers insight into institutional legitimacy and the challenges of aligning policy with student beliefs.

*The Developmental Case for the Right to Be Forgotten.* Drawing on developmental psychology, this paper argues that adolescents and emerging adults require legal mechanisms—such as the right to be forgotten—to support identity development, autonomy, and reintegration after mistakes made during formative years.

*Beyond Static Consent: A Dynamic Framework for Withdrawal and Contextual Shifts in Sexual Communication.* This paper challenges fixed models of sexual consent by examining how consent can change over the course of an encounter. It proposes a dynamic framework that accounts for withdrawal, evolving communication, and the contextual cues that shape sexual decision-making.

*Beyond Group Averages: Centering Individual Justice in Juvenile Risk Tools.* This paper critiques the dominant reliance on group-based statistical patterns in juvenile risk assessment instruments and argues for incorporating principles of individual fairness. Drawing on developmental science and legal theory, it explores how risk tools can obscure personal context and reinforce structural inequities and proposes strategies to better align these tools with individualized justice.
